Eight notes at the beginning of this book:

1.) As an atheist, communist and biophysicist (72 years old), I will consider man (Homo sapiens) as a programmable biological machine like other animals and will also take into account his different genetic varieties.

- 2.) I will not take into account our cultural-civilization habits. I will try to write this book as a nondiplomatic alien who will not be burdened by our culture, ethics, laws, rules, fears and taboos.
- 3.) I will argue that there is much verifiable evidence that contemporary democracy coupled with capitalism creates the conditions for genetic predators of Homo sapiens to enter power structures, and it is the source of democratic crimes against humanity. Finding predator genes would be useful for the foundations of a new human civilization.
- 4.) I will present verifiable facts about the incredible communist miracle of the new humane socialist civilization in Eastern Europe and verifiable facts about the terrible crimes of totalitarian democracy after Maidans ~1990.
- 5.) Because the current anti-communist totalitarianism wants to remove the memory of socialism in the former Eastern European countries, the goal of the book is to preserve the data about the communist miracle of the new humane socialist civilization, especially in Slovakia in the years 1948-1990.
- 6.) My opinion about the USA, NATO and other countries is about their foreign policy and not about the nice people who live there. My opinion about religions is about their involvement in politics and not about ordinary believers.
- 7.) Elected democratic leaders in many capitalist states are merely mouthpieces for the financial-industrial-military complex.
- 8.) For simplicity's sake, I'll refer to the untouchable genetic predators and their high-powered supporters as the Segregated Chosen Hamburger. The Segregated Chosen Hamburger has many positive outcomes. It has contributed to and often ensured the development of education,

science, technology, etc., leading to new technological products in all areas of our lives. What many do not realize about the positive impact of the Hamburger is that these technological and health advancements lead to improved living conditions for the majority of the world's people. The positive effect of the Hamburger is well known, but its negative effect is not so well publicised in the mass media. Therefore, in this book I will only describe the negative impact of the Segregated Chosen Hamburger on our civilization.

Overview

The facts presented in the book show that capitalism and free elections are the basis of democratic serfdom and they ensure that people (programmed biological machines) who have the genetic makeup in the brain of predators often get into positions of power. I will call them the Segregated Chosen Hamburger. This is how the predators of today's capitalist democracy ensure the exploitation and unequal distribution of the planet's income and wealth. For this purpose, they are trying to ensure professional absolute mental, political and economic totality in the countries they have predatorily occupied. They create cyber and real wars where they see other programmable biological machines (humans) as nothing more than prey. The capitalist system ensures that they can do this with impunity and call it democracy. Genetic predators know very well that they have only one mortal enemy and that is the nationalization of their property, and therefore they spread anti-communist propaganda wherever they can. I often ask why representatives of the media, businessmen and cultural institutions kept repeating to us that free democratic elections are the basis of well-being in all areas. But, paradoxically, they are deathly afraid of introducing free democratic elections into their institutions, because they know that it would be a disaster for them.

Sometimes I feel that today's capitalist democracy has enough elements from the Western European Christian Inquisition that burned witches for 350 years. I wonder if the Western European rulers since then do not have the same genes.

For the sake of simplicity, in this e-book I will call communism everything that is extremely left-wing, such as socialism, where communist parties ruled including communist People's Republic of China. In this e-book, I will show facts from a real experiment from Eastern Europe, where capitalist countries adopted a political-economic system of socialism (after 1917 or ~1948) and after several decades of socialism in ~1990, they became capitalist again. In the book, I will present demonstrable evidence that these countries were poor under capitalism, developed under socialism, and after the coup (1989) under current capitalism, they have many humanitarian problems. I will mainly use data from Slovakia as a model for these Eastern European countries. Similar results can be observed in other countries of the former Eastern Europe. Quite simply, the goal of the Euro-Atlantic civilization to destroy the Eastern Europe socialist civilization was so far accomplished.

The facts presented in the e-book show that socialism has playfully solved all the intractable problems of capitalism, such as the division of people into segregated elites, the middle class and the subhuman. Socialism eliminated crimes such as selling people for work or the sex industry, homelessness, arson, contract killings, drug addiction, violence,

executors or psychological problems out of hopelessness. All these crimes against humanity appeared in Slovakia and in other former Eastern European socialist countries immediately after the Maidan 1989-1990 when democracy and capitalism were introduced there. The book also compares the influence of the Russian 'occupation' of Slovakia during socialism (1948-1989) with the influence of the Western 'occupation' of Slovakia during capitalism after 1989.

After Maidan (1989), the most serious crimes of capitalism were introduced in Slovakia, namely the starting extinction of Slovaks and damage to their genetic code, as the age of first-time mothers increases. Last but not least, it is an effort to raise a new generation of programmable biological machines (democratic serfs) who mentally function only in the range of animal instincts, to eat, drink, poop, pee and have sex.

Simply, the e-book is proof that the political-economic system - socialism (at least in Slovakia) compared to capitalism, was a communist miracle of the new humane socialist civilization in Eastern Europe. This fact is very dangerous for some current ruling genetic democratic predators and is therefore a great taboo of democracy.

The book is updated and it is a partially continuation of my previous book (1) and I took parts from my book published in Slovak (2). It will cover mostly 40 years of socialism (~1948-1990) and about 20-25 years of capitalism (~1990-2015).

This book asks and discusses other taboos of democracy that are not openly discussed, such as: is Euro-Atlantic civilization also built on genetic predators that, regardless of other programmable biological machines, are leading civilization to destruction? Is there a Segregated Chosen

Hamburger? Is the European Parliament part of the totality of genetic predators and does it have elements of neo-Nazism? What are the genes of human predators or Nazis? Has totalitarian democracy declared war on freedom of speech? Is the foreign policy of the USA and its NATO allies, which everyone fears, in some cases professionally deliberately criminal? Why do their crimes against humanity go unpunished? Is contemporary capitalist democracy a compulsory totalitarian system? Can capitalism solve the present problems of our civilisation? Is the capitalist white race a dead branch of Homo sapiens? Is there a genetic Homo idioticus and a Homo communist? Why is the Segregated Chosen Hamburger afraid of a communist miracle in China? And finally, can the current problems of our civilization be solved by a new future socialist political-economic system with: Chinese, European or American... characteristics?

Introduction

I have lived in Slovakia for thirty six years during socialism till 1988 and now thirty four years under capitalism. During socialism I did not pay much attention to politics, but I started to be interested about socialism during my five years of working in the field of biophysics in the universities in USA. This took place between the periods of 1988-1996, when I shuttled between the USA and Slovakia and results was that I have joined Communist Party of Slovakia in 2000. As a scientist in the field of biophysics, co-author of >130 scientific articles, I started studying socialism as a hobby, what it has been about. I have observed that socialism was the incredible communist miracle of a new humane socialist civilization with comparison to the past and recent capitalism. I observed

that these economically and politically different systems each produced a different kind of society. And this is what this book is about.

After the transformation of socialism to capitalism in 1989, I was surprised by the unexpected changes, most of them negative ones that capitalism had brought into our daily life. Most importantly, I found that capitalism changed people's behavior, formed a new negative social culture, and formed a new capitalistic society that is, according to the data I present, less humane and civilized than the previous socialist society.

Many books and articles present theories and conclusions criticizing real socialism in former socialist countries by emphasizing the crimes of communism, repeating how socialism was a criminal system limiting human rights. Interestingly, the most of the book's authors never lived under socialism or lived in countries under the transition of socialism to capitalism. Instead of a real discussion about socialism versus capitalism, many of them repeatedly presented limited facts, mostly lies and myths about the totalitarian communist regime, the crimes of communism and the failure of socialism. Most of the time, when I have discussed socialism with left-leaning political activists in the West, I have been surprised at how deeply they have been brainwashed by the ubiquitous anticommunist propaganda.

Usually when I read books or watch TV documentares describing socialism in the former socialist countries as a "criminal, totalitarian and inhuman communist regime, under which people were living without freedom, human rights, or democracy", I am very surprised and cannot understand the descriptions. I cannot find statistical data or use my personal experience to support this general view.

Now I know that all these lies were purposefully produced by the Euro-Atlantic civilization, for whom we Eastern Europeans were just the spoils that slipped through their hands during socialism. The aim of these lies is to bury socialist or communist ideas as they are very dangerous to the current global 'democratic' world of the Segregated Chosen Hamburger that suits only a few. The Segregated Chosen Hamburger perpetuates today's capitalist democracy because it is the foundation of exploitation, increased inequality, modern democratic serfdom, and the legalization of capitalist crimes that suit the few who rule capitalist democracy.

Now when former socialist countries are transformed into capitalist ones, it is easy to compare how the transition affects the economy, human rights, freedom, happiness, satisfaction and the whole economic, cultural and social life of the people. It is easy to compare the crimes of communism with the crimes of recent democracy. I know of few true studies comparing the outcome of a real socialist experiment in former socialist countries versus real capitalism in the same countries. But I found that the official media coverage of these studies is strictly prohibited.

These lies, myths and anti-communist totalitarianism provoked me to write this e-book, in which I would like to present real verifiable data that proves that socialism was the communist miracle of the new humane socialist civilization in Eastern Europe compared to previous or current capitalism.

Chapter 1: East European countries - some data from history

For simplicity, I will call people from Eastern Europe Slavs.

There are reports that in ancient times Slavs (sometimes castrated) appeared in slave markets in Western and Southern Europe and Asia for many years. As Parenti (27) says, "The people Charlemagne worked to death in his mines in the early part of the ninth century were Slavs. So frequent and prolonged was the enslavement of Eastern Europeans that "Slav" became synonymous with servitude. Indeed, the word "slave" derives from "Slav". Eastern Europe was an early source of capital accumulation, having become wholly dependent upon Western manufactures by the seventeenth century".

Is it true that the word Slav has become synonymous with the word slave in many Western European countries? Probably it is. It may be supported by data from the last 500 years, which show that Eastern Europe was under the economic influence of the West.

For example: Eastern Europe of the Slavs was a backward Western European colony in Russia until the Bolshevik Revolution of 1917. Colonizers in Russia alone, in 1914, owned 90% of mines, almost 100% of oil extraction, 40% of the metallurgical industry, 50% of the chemical industry, 28% of the textile industry and 42% of securities in banks. In Tsarist Russia in 1913 only 30% of the population could read and write, which was much less than in England in the middle of the 18th century. In

1913, life expectancy at birth in Russia was around 35 years. For comparison, 60 years in the Netherlands, 50 years in the USA, 57 years in Austria, 55 years in Sweden or 30 years in China. Infant mortality in 1913 in the Russian Empire was 273 children per 1,000 births. Production per capita in Russia in 1913 was only 4.7% of the USA, 7% of England, 8% of Germany. The average income per capita of the Russian Empire in 1913 was comparable to the income in 1686 in England. The foreign debt of the Russian Empire was 80,000,000,000 gold rubles, i.e. 2/3 of all the property of Russia (Bolsheviks canceled the Russian national foreign debt on 28.1.1918). And it could have remained this way until now, if not the Bolshevik Revolution in 1917. The Bolsheviks even achieved that in the 80s of the 20th century, the ratio of Russian (Soviet) production to the USA was already 1:3, and not 1:12 as in 1921 (3).

I compared data on the manufacturing output of countries in the world from 1920 to 1938 published in (4). I selected four countries and data for the whole world and I drew a Figure 1, where I put 100% the manufacturing output in 1920 for all countries. From the picture you can see that the development of the manufacturing output of the USA, Great Britain, Germany and the whole world was very similar, which speaks of the interconnectedness of the economies. Production fell during the Great Depression of 1929-1932 and then began to rise. Only the economic growth of the Soviet Union was incomparably higher, so I had to draw Figure 2. It can be seen from the picture that the economic growth of the Soviet Union, which was independent of West economy, was not affected by the economic crisis of 1929-1932, and many times exceeded the growth of the most advanced capitalist countries of the world.




In general, two arguments can appear for the high growth of the Soviet Union's manufacturing output. The first is that it is easy to report high production increases in percentages in countries that had a low production base to begin with. This argument probably does not apply, because then all poor developing countries would have to achieve equally high production increases. The second argument is that the high growth of manufacturing output in the Soviet Union was achieved thanks to a totalitarian system that violated basic human rights. It can be said that way, although many things are debatable. Interestingly, it is often forgotten that the economic growth of Western industrialized countries in this and previous periods was also due to a totalitarian system that violated basic human rights in their colonies or otherwise conquered countries.

A few examples from Slovakia before the communist takeover in 1948, which no one must know

For last 34 capitalist years, the ubiquitous capitalist lies keep telling us that as socialism it lagged behind capitalism in Western Europe. Therefore, due to absolute information totality after the Maidan in Slovakia in 1989 and absolute brainwashing (which I will explain later), the following data from capitalist Slovakia in the years 1918-1948 are forbidden to know. In this way, the propaganda could implicitly lie that during capitalism in Slovakia (1918-1938) the standard of living in Slovakia and in Western Europe was similar.


But true is that capitalist Slovakia, during 1918-1938, was a poor, economically, educationally and culturally underdeveloped country in comparison to developed capitalist counties. An estimated gross domestic product (GDP) per capita in purchasing power parity (PPP) in Slovakia during 1925-1934 was 2-5 times lower than in developed counties (Figure 3). The difference between Slovakia and the developed countries were

gradually reduced during socialism, and in 2001 the deference was reduced even more, as seen in the Figure 4.

Industry production in Slovakia per capita in 1938 was around 15-20% of Germany, Great Britain or France (data calculated from (5). The illiteracy rate was 15-20% in 1921 (6). Living standard and industrial development of Slovakia during 1918-1938, estimated as consumption of electric energy per capita, was behind developed countries (Figure 5). The electric consumption per capita in 1935 in Slovakia was only 42% of Czech, 22% of Austria, 21% of UK and 19% of Germany (Figure 6). The difference of electric energy consumption between these countries significantly decreased during socialism as shown in Figure 7, for 1980, when Slovakia reached 87% of the electric consumption of Austria.

Poor economic conditions during capitalism before 1939 led to poor health conditions and increased mortality. The infant mortality rate in 1937, in Slovakia and other eastern European backward capitalist countries was high in comparison to the developed countries (Figure 8). It was 151 infant (under 1 year of age) deaths per 1,000 live births in Slovakia versus 40-80 in Western European countries. Results of the poor living conditions in Slovakia (3-3.5 mil. population) was the emigration of 204,000 people to the USA and Western Europe between 1918-1938. The differences between many socialist countries, including Slovakia, and developed countries decreased during socialism indicating health improvements in socialist countries (Figure 9). Poor health conditions are also documented by the comparison of the number of deaths per capita in Slovakia, caused by tuberculosis and pneumonia. In the years1921-1925, deaths were about 2-times higher than in Western European countries (Figures 10,11). During socialism numbers of deaths due to infectious and

parasitic diseases and number of people per 1 physician decreased significantly (Figure 12,13).




